Biographical Outline

Mr. Petsas presently owns and operates Petsas Commercial, LLC, a private real estate firm focused on development and acquisition of industrial real estate in Greater Phoenix.

From April 2000 to February 2017, he was Senior Vice President of EastGroup Properties, Inc. where he had responsibility for developments, acquisitions, dispositions and oversight of all day-to-day activities for the Western Region, which included Phoenix, Tucson, San Diego, Los Angeles, Santa Barbara, San Francisco, Fresno and Denver.

From July 1994 to April 2000, Mr. Petsas was a Vice President with Prologis, Inc. and responsible for all development, acquisition, leasing and management of the Phoenix portfolio.

From January 1992 to July 1994, he co-founded Excel Advisory Group, which provided due diligence consulting services to Security Capital Industrial Trust, the predecessor to Prologis, Inc.

From June 1986 to May 1991, Mr. Petsas worked with the industrial division of Trammell Crow Company in Phoenix where his day to day activities included leasing vacant industrial space, renewing industrial tenants, oversight of property management, and oversight of tenant improvement construction.

From June 1980 to June 1983, he worked with the Chicago office of Arthur Andersen & Company performing audits of the firm's utility clients. He passed the CPA exam and was licensed in the State of Indiana.

Mr. Petsas received his undergraduate degree in Accounting from Valparaiso University in 1980 and an M.B.A. from Indiana University in 1986.
