## 2. STUDY SESSION ITEMS

#### 20-086 Discussion of Lincoln Drive Median Landscape Improvements

Town Engineer Paul Mood updated the Council on the Lincoln Drive median project to reconstruct medians between 32<sup>nd</sup> St and Mockingbird Ln; realign the intersection of Invergordon Rd and Lincoln Dr; and enhance the crosswalks at Lincoln Dr and Tatum Blvd consistent with the Visually Significant Corridor Master Plan. There was Council consensus to:

- 1. Proceed with left turn phasing for eastbound and westbound Lincoln Dr at Invergordon Rd
- 2. Bring back alternative crosswalk designs for Lincoln Dr and Tatum Blvd that were more understated than the initial proposals
- Prepare an intersection design and cost estimate for Lincoln Dr and 56th St.
- 4. Investigate awarding a Job Order Contract to expedite construction

# 20-092 Discussion of Development Agreement for Lincoln Plaza Medical Center

Town Manager Jill Keimach and Assistant Town Attorney Deborah Robberson summarized the terms of the proposed development agreement with Lincoln Plaza Medical which included the following terms. Lincoln Plaza Medical Center commitments:

- 1. Dedicate 40' of Lincoln Drive to the Town
- 2. Grant the Town a sidewalk and utility easement for an enhanced sidewalk plan
- 3. Execute and record a Shared Access Agreement with Smoke Tree (Gentree) to construct and pay for a shared driveway serving both properties
- Construct at its own cost sidewalks, landscaping, shared driveway and closure of driveways

Town of Paradise Valley commitments:

- 1. Dismiss its quiet title/condemnation action related to the 40' dedicated roadway
- 2. Provide for existing monument sign to remain within the sidewalk easement area (with future alterations through normal SUP procedures)
- 3. Include Sidewalk Easement Area in future FAR and lot coverage calculations
- 4. Provide median for Left In/Left Out access from shared driveway

Ms. Keimach stated that the agreement is scheduled for a vote later in the meeting.

#### 20-100 Discussion of Ambulance RFP

Ms. Keimach and Ms. Robberson summarized the proposed request for proposal for ambulance services. Ms. Robberson noted that the Town is consulting with Matt Zavadsky, EMS Senior Association with the Center for Public Safety Management, LLC, who attended the Study Session by telephone conference call. There was Council consensus to authorize staff to issue the RFP.

# 20-098 Update and Discussion of the Capital Improvement Program and Financial Plan

Chief Financial Officer Douglas Allen updated the Council on public and private options and rates to issue bonds. There was Council consensus to direct staff to bring back a resolution on March 12, 2020 authorizing a \$8 million bond issuance for a 6 or 6.5 year bond and callable after four years. The Council favored private placement unless there was a material difference in final interest rates.
