The construction at 6400 E Cactus Wren Road will continue for a number of years, and the surrounding neighborhoods of the La Place HOA, Vista Camello HOA, and four homes on E. Cactus Wren will all be significantly impacted on a daily basis.

The intersection of Invergordon Rd. and E. Cactus Wren Rd. serves as the ONLY entry and exit point for 39 homes, and we believe the restrictions on parking along E. Cactus Wren Road addressed in Condition 6 will mitigate safety concerns. Historically, large construction trucks in the area have contributed to blocking access and reducing visibility.

The plan to control water runoff, and address drainage and grading will also contribute to a safer project site, and reduce impact on surrounding roads. While a storm water plan has been developed, we expect its effectiveness to be periodically monitored.

During the study session, additional concerns were raised by council members, including dust control, construction staging, and location of additional transformers. We expect that dust control will comply with Maricopa County standards. The inclusion of a condition on construction staging will also be beneficial. We want to ensure that a transformer is not located on the corner of Invergordon Rd. and E. Cactus Wren Rd. As so many vehicles pass through that intersection, safety is of great concern. Vehicles regularly disregard that stop sign, and the potential for an accident near a transformer must be minimized.

We also want to ensure the condition of Invergordon Rd. and E. Cactus Wren Rd. will continue to be maintained to at least their current state.

The La Place HOA supports the development of 6400 E. Cactus Wren Rd. (Estates on Invergordon) and we appreciate the support of Town Council to ensure the project causes minimal disruption to our neighborhood during the years the project will be under construction.



Paul – I received this from one of the neighbors through our client, La Place HOA. I talked to Omar and he gave me the feedback below. It sounds like the stip language doesn't match the P&Z intention. Do you have an audio of the hearing and can you review and then just correct the stip? I have seen that done before many times over the years as often stips on the fly aren't crafted precisely but the intention is very clear from the governing body....Let me know and thanks!

FROM OMAR: Jordan: I agree that no parking on the paved surfaces of Cactus Wren or Invergordon seemed to be what was settled on. I looked at my notes again and I have written that 6(d), which previously said there was to be no construction parking on Cactus Wren except for Lot 1, was stricken. Cactus Wren was then moved to 6(e), which initially only mentioned Invergordon, and would now say something along the lines of "No parking on Invergordon or Cactus Wren on any paved surfaces."

The way it has been drafted I think it only clearly prohibits parking on the paved west portion of Invergordon and the paved south portion of Cactus Wren. The inference then is that someone could park on the NONpaved western portion of Invergordon, paved east portion of Invergordon, or north paved portion of Cactus Wren. This might allow parking on nonpaved areas in front of Maryann's home which she specifically didn't want and the commissioners agreed. I recall

the commissioners also agreed that parking on the paved east side of Invergordon would be a hazard due to the narrowness of the road, and that parking on Cactus Wren was an issue due to it being La Place's only road for access.

The above discussion is what led to the commission's addition of condition 6(h), which requires a designated construction area to "prevent parking on any paved public street surfaces." It is clear that what was drafted doesn't meet the intent of the discussion.

I appreciate you taking the time to review the conditions. It is always good to have another set of eyes looking at things. The short version is that the condition is drafted correctly, but staff agrees when the final plat goes to Council it will be suggested that Council modify this condition since it does not fully meet the intent discussed by the Commission.

I went back to the notes taken during the meeting (Includes my notes, the notes from Commissioner Wastchak, and the Town Attorney) and watched the video again to verify the wording. The wording for Condition 6.e is how it is drafted that reads "Construction parking shall not be allowed along the west side of Invergordon Road and the south side of Cactus Wren Road on any paved surfaces. Any non-paved surface used for construction parking shall conform to storm water pollution prevention plan requirements."

If you watch the video go around time 2:01:30 where Commissioner Wastchak brings up the edits, 2:02:50 where you speak, 2:04:30 where Commissioner Wastchak revises the condition based on your input, and 2:08:00 where Andrew Miller recaps the edits to the conditions.

The wording you have was an earlier version, but was not in the final version of that condition from my relistening of the video.

I would agree that as the condition reads as approved, it does not fully meet the intent of the discussion points agreed as a recommendation by Commission. As approved, it may lead one to infer that someone could park off pavement on the west side of Invergordon or park off pavement on the south side of Cactus Wren which was not the intent. It also does not capture the intent that there should be no construction parking on the east side of Invergordon on the paved surfaces. My recollection is the Commission was ok with parking on the north side of Cactus Wren even on the pavement, provided the parking was not in the area of the median or blocked the travel lane.

The good news is that these conditions carry forward with the final plat that has yet to

be filed. The conditions act like placeholders for what Council will approve with final plat. I think there is merit to have Council discuss and have them consider modification of that condition with the final plat. Staff cannot modify any conditions as worded with the preliminary plat. Staff will note this point and draft up an alternative condition in the staff report for the final plat.

Call me if this does not make any sense.

Thank you for sending along the approved conditions as revised by the Planning Commission. Based on my notes and recalling the decision o the Commissioners stipulation 6 e is incorrect as currently drafted.

The current language in the document you sent to me reads as follows:

• Construction parking shall not be allowed along the west side of Invergordon Road and the south side of Cactus Wren Road on any paved surfaces. Any non-paved surface used for construction parking shall conform to storm water pollution prevention plan requirements;

My understanding of the condition that was approved is the following:

Construction parking shall not be allowed on any paved surfaces along Invergordon Road or Cactus Wren Road. Any parking on non-paved surfaces along Invergordon shall be restricted to the east side. Any non-paved surface used for construction parking shall conform to storm water pollution prevention plan requirements;

As currently drafted parking would be allowed on the paved road on the east side of Invergordon and the north side of Cactus Wren. That was not what the Commissioners approved. They also agreed that construction parking should not be allowed on the east side of Invergordon where we have installed stones and plants.

I do hope this can be revised to reflect the vote and approvals of the Planning Commission. Thank you very much.

Staff and the Planning Commission appreciate you taking the time to comment.

For your records, attached are the approved conditions as revised by the Planning Commission for the Estates on Invergordon preliminary plat.

As I noted at the meeting, these conditions generally carry over with the final plat to Council.

The next step is for the applicant to make final plat submittal. Staff will review the submittal and once deemed complete schedule the meetings for Council study session and Council action. Property owners within 1,500 feet will again get notice of the meeting action will take place. Notices are mailed at least 15 days prior to that meeting. There is no mailing notice of the Council study session, but whomever emailed me I added to this email list and will email you with both the Council study session date and Council action date once these are set. FYI, public comment at Council study sessions are rare, but they are open to the public to attend and listen. Public comment opportunity is generally at the action meeting. Further grading accompanying development and the removal of the remaining walls will compound this problem. The force of water has been enough to wash river rock from the property at 6431 E. Cactus Wren into 65th St., creating hazardous road conditions for the 26 homes of La Place that must use 65th St. to get onto E. Cactus Wren to enter and exit the development. How will the Town, the property owner, and the developer(s) address this concern?
