Good morning George,

My name is Jon Fisher and I am part of the Land Acquisition and Development team at Shea Homes. As you know, we are the developer and owner of Azure. With our location being next door to the church, the church has done a fantastic job being great neighbors as they have embarked on their minor amendment to their SUP. Starting in November 2019, they invited Shea Homes and all current residents of Azure to an information session on their plans for the SUP. During this session, they unveiled the plans to install a solar panel shade sail over the playground onsite. Shea Homes does

object to this portion of the proposed SUP, however, the church went above and beyond in securing renderings for a canvas shade sail that is a better solution in our eyes due to the apex of the shade sail being lower than that of the solar panel and less impactful, which we do support.

I have had more than one conversation with the church's project team and they have had very open and honest conversations with us on their project as a whole, and over our concerns, which is appreciated. Aside from the currently proposed solar panel shade sail, we do support the SUP amendment.

Thanks for your time and your consideration of our concerns regarding this matter.

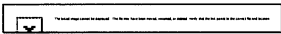
