NATIVE PLANT PRESERVATION

- Multiple Locations in Town Code that Address Preservation
 - Town Code Section 5-8-4 Single-Family Home Construction
 - Zoning Ordinance Article 22 Hillside Development
 - SUP Review and Stipulations

 Proposed code change is focused on the regulation of native plants during the construction of single-family homes.



NATIVE PLANT PRESERVATION

- Implementation <u>during demolition and construction phases</u> of new homes
 - Any new home or remodel/addition greater then \$500,000 requires a Native Plant Preservation Plan
 - Plan includes an aerial photograph and/or site plan showing all protected native plants within area of disturbance
 - Lists number, species, size, and condition of protective native plants
 - Narrative explaining relocation (if necessary)
 - Reviewed by the Building Division as part of plan review
 - Inspected at Building Final to ensure remain



CURRENT PROTECTED PLANTS

Currently Town Code 5-8-3 Specifically protects trees that are over 4 inches in caliper

White Thorn Acacia Foothill Palo Verde Ironwood Catclaw Acacia Blue Palo Verde Mesquite

Barrel

And Cacti which are three feet or greater in height

Saguaro Ocotillo

Desert Night Blooming Cereus



PROPOSED ADDITIONAL PLANTS

Staff suggests adding the following trees that are over 4 inches in caliper

Red Barberry	Cruxifiction Thron
Desert Hackberry	Desert Willow
Juniper	Cottonwood

And one additional cactus, Soaptree Yucca

Additional Trees and Cactus are identified by the Arizona Department of Agriculture and included in the Administrative Code for the State of Arizona

Also add clarification in the Grading and Dust Control Regulations requiring Native Plant Preservation Plan



PROPOSED CODE LANGUAGE

<u>Section 1</u>. Chapter 5, Building, Article 5-8-4, Native Plant Preservation, is hereby amended (with deletions shown as strikethroughs and additions shown in **bold type**):

A. Protected native plants

Trees which are over four (4) inches in caliper of the following species:

Acacia Constricta
Acacia Greggii
Cercidium Microphylum
Cercidium Floridum
Olneya Tesota
Prosopis Species
Berberis Haematocarpa
Celtis pallida
Juniperous species
Canotia holocantha
Chilopsis linearis
Populus fremontii

White Thorn Acacia Catclaw Acacia Foothill Palo Verde Blue Palo Verde Ironwood Mesquite **Red Barberry Desert Hackberry Juniper Cruxifiction Thron Desert Willow Cottonwood**

Cacti which are three (3) feet or greater in height of the following species:

Carnegiea Gigantean Ferocactus Species Fouquieria Splendens Peniocereus Greggii **Yucca elata** Saguaro Barrel Ocotillo Desert Night Blooming Cereus Soaptree Yucca

PROPOSED CODE LANGUAGE

<u>Section 2</u>. Chapter 5, Building, Article 5-10-5, Grading and Dust Control Regulations, is hereby amended (with deletions shown as strikethroughs and additions shown in **bold type**):


- 2. No land disturbance may occur on any lot or parcel in the Town without a grading permit being first obtained from the Town Engineer, and, if necessary, a hauling permit and payment of the hauling permit fees, as prescribed in the "Town of Paradise Valley Fee Schedule," except as otherwise provided herein. No grading permit may be issued without the following submittals, each in a form approved by the Town Engineer:
 - a. A grading plan prepared by a Civil Engineer.
 - b. Dust control plan meeting the requirements of Rule 310 of the Maricopa County Air Pollution Control Regulations, as amended.
 - c. A native plant inventory, native plant salvage plan, and revegetation plan using plants from the Town's approved plant palette **in accordance with Article 5-8-4 of the Town Code**.
