15	NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL
16	OF THE TOWN OF PARADISE VALLEY, ARIZONA AS FOLLOWS:
17	WHEREAS, the Town Council desires that certain public bodies of the Town, that
18	is, the Planning Commission, Board of Adjustment and Hillside Building Committee, have
19	rules of procedure that are similar so that Town residents, applicants, and the general public
20	would have an expectation of similar rules in their dealings with each of the Town's public
21	bodies; and
22	WHEREAS, in addition to adopting the most current set of Rules of Procedure used
23	by the Board of Adjustment, the Town Council desires that changes be made to those Rules
24	of Procedure that will address problematic issues such as: 1) the late submittal of materials
25	by applicants or residents/general public; 2) surprise submittals of documents or electronic
26	materials on the night of a Board of Adjustment meeting; 3) lack of clarity on allotted
27	speaking times for "spokespersons" for residents or neighborhood groups; and 4) clarity on
28	timing requirements and agenda setting requirements for motions to reconsider a motion or
29	action from a prior meeting; and
30	WHEREAS, adoption of uniform rules for each public body and addressing needed

1	changes will help staff, residents/general public, applicants, and the public bodies maintain
2	greater transparency, predictability, and openness as well as providing for a more rigorous
3	and thorough review of submitted materials by the Town staff and ensuring that all parties
4	have sufficient time to review materials submitted for public review prior to scheduled
5	Board of Adjustment hearings or meetings.
6	NOW, THEREFORE, BE IT RESOLVED that:
7	1. Pursuant to the provisions of Town Code §2-5-3.C the Town Council hereby
8	approves and adopts the Rules of Procedure for the Board of Adjustment of the Town of
9	Paradise Valley.
10	2. This Resolution shall take effect thirty (30) days after its adoption.
