1. CALL TO ORDER / ROLL CALL

Mayor Collins called to order the Town Council Meeting for Thursday, May 25, 2017 at 12:01 PM in the Town Hall Boardroom.

2. EXECUTIVE SESSION

Discussion of Town Manager and Town Attorney Performance Reviews as authorized by A.R.S. §38-431.03(A)(1) and Town Manager and Town Attorney contract negotiations as authorized by A.R.S. §38-431.03(A)(4).

3. STUDY SESSION ITEMS

17-187 <u>Discussion of a Proposed Subdivision Monument Sign and Wall Sign for Camelhead</u> North

Senior Planner Paul Michaud presented a proposed subdivision monument sign and wall for the Camelhead North neighborhood association located at 4816 E Arroyo Verde Drive and 4600 E Pebble Ridge Road.

The Council discussed sight visibility concerns in detail. It was suggested that the Town changed the current code requirement if it is not a reasonable standard and cannot be met. Town Engineer Paul Mood suggested deferring to the AASHTO standard which is a formula derived from setbacks, speed, and other variables to determine the appropriate height and distance of structures in the right-of-way. There was consensus to direct staff to draft amendments to the "corner vision" section of the Town Code.

The item was scheduled for Council action on June 8, 2017.

17-178 Discussion of Sanctuary Resort Special Use Permit Amendment

Planner George Burton presented a request to amend the Special Use Permit for Sanctuary Resort and Spa to allow for additions to the existing casitas, two new casita buildings, a new pool, a new snack bar, modified parking, and additions to the existing ballroom building, and the addition of storage containers.

Mr. Burton stated that the proposed amendments are consistent with the General Plan, Zoning Ordinance, SUP Guidelines, and the Statement of Direction. The Planning Commission voted unanimously on May 2, 2017 to recommend approval of the amendment with stipulations.

The Council focused its discussion on landscaping along McDonald Drive and the oleanders screening the new storage containers. Council directed staff to add a stipulation limiting the number of storage containers to five, requiring a managerial amendment for a landscaping plan with objective standards

consistent with the 56th Street design, and a plan to remove or screen the storage containers if the oleanders die.

Council action on the SUP was scheduled for June 8, 2017.

17-180 Discussion of The Villas at Cheney Estates Private Roadway Gate Statement of Direction

Senior Planner Paul Michaud presented a request from Doug Jorden, P.C. on behalf of Town Triangle, LLC for a private roadway gate Special Use Permit near the northwest corner of the Northern Avenue alignment and Scottsdale Road. Mr. Michaud discussed alternative draft statements of direction for Council consideration, supporting and opposing private roadway gates.

Council discussed the Statement of Direction process for SUPs as they relate to concurrent applications for land use and zoning amendments. The Council directed that the Statement of Direction emphasize that the Council's consent to allowing the Planning Commission to consider the private gate does not constitute support for the associated zoning applications. The Council also asked staff to research including a reverter clause in the SUP to revert approval of the private gate if the zoning applications do not get approved or if the project is not built within a certain period of time.

The Statement of Direction would be scheduled for action on June 8, 2017.

17-193 Discussion of Lighting Code Revisions

Community Development Director Eva Cutro presented proposed amendments to Zoning Articles 10 and 25 regarding lighting. She said that certain portions of the lighting code were outdated and did not reflect current standards while other changes were "housekeeping in nature. The amendments included the following:

- A purpose statement has been added
- · A definition section has been added
- All references to watts have been changed to lumens
- A provision for holiday lights has been added
- Light measurements can now be computed in both Footcandles (existing measurement) and Lux (new measurement)
- Sign regulations have been tightened:
 - o Sign lighting permitted only during business hours
 - Kelvin measurement added to prevent bright, blue/white lighting
 - Non-opaque, back lit signs now prohibited

The Council noted that municipal buildings in Town do not meet the lighting standards for non-residential properties. There was consensus to research placing timer switches on outdoor lighting for government buildings. It was also noted that many street lights, like those along the Tatum Curve, are very bright

and do not meet the new Kelvin standards. However, those lights are owned by utility companies and were recently replaced with energy saving LED lights.

The lighting ordinance was scheduled for action on June 8, 2017.

17-197 Review of a Cell Service Statement of Direction (SOD)

Town Manager Kevin Burke presented the proposed Statement of Direction for the Planning Commission's review of amendments to the Personal Wireless Service Facilities section of the Zoning Ordinance.

The Council discussed objective standards for small cell facilities in the right-of-way. There was consensus for the Code to reflect a preference for 24-foot faux cacti installations in the ROW with appropriate landscaping. Attention should be given to placement of all installations to provide separation from streets and sidewalks. Also, the design palette should be similar to 56th Street.

The Council discussed timing for review and adoption of the new ordinance. Because August 8 was the effective date for the new state law, Council directed that the Commission complete its work in mid-July so the Council could take action in early August. The Council discussed scheduling a special meeting in August for adoption.

The SOD was schedule for action on June 8, 2017.

Mayor Collins recessed the meeting at 6:00 p.m.

17-191 Adoption of Ordinance Number 2017-04; Amending the Phoenix Country Day School Special Use Permit

Community Development Director Eva Cutro presented an amendment to the Phoenix Country Day School Special Use Permit to add a new Administration Building, security fencing, and signage. She stated that the proposed changes are consistent with the General Plan, Zoning Ordinance, SUP Guidelines, and Statement of Direction. The Planning Commission voted unanimously to recommend approval. The SUP before the Council included amendments offered by the Council to enhance landscaping around the new sign and prohibit new signs at the other ingress/egress locations.
