17-377 Arbor Day Tree Planting

TOWN COUNCIL MINUTES

Affairs summarized the Town's legislative efforts in 2017. The Council discussed their priorities for the 2018 legislative session including: transaction privilege tax / construction sales tax / MRRA; zoning & preservation of quality of life; pension reform; use of the public right-of-way; public safety/smart technology; and preservation of state shared revenues. The Council directed staff to bring back a revised document prior to the annual legislative breakfast prioritizing and categorizing the issues.

17-376 Governance - Discussion #5

The Council continued their discussion of the Council Rules of Procedure. They finalized the amendments related to the number of members necessary to place an item on a future agenda, the process to add items, and expectations for staff research on items sponsored by less than a majority of the Council.

The Council discussed the rule governing which items must be heard in a study session prior to taking action. Currently only ordinances and Special Use Permit must be heard in study session prior to action. There was Council consensus to also require new statements of direction and plats. There was agreement that plats could be placed on the consent agenda for action.
