#### 2. STUDY SESSION ITEMS

18-038

Mayor's 2018 Volunteers in Paradise (VIP) Strategy - A Discussion and Possible Action on the 2018 Committee, Commission and **Board Appointment / Reappointment Process** 

Mayor Collins presented his "Volunteers in Paradise" strategy for 2018. A plan to recruit, interview, and appoint volunteers to the Town's committees, commissions, and boards. The Council suggested minor edits to the strategy. There was consensus to proceed as the Mayor suggested.

The Council reviewed the list of vacancies and terms expiring in March 2018. There was agreement to combine the review process for the current vacancies on the Planning

Commission and Advisory Committee on Public Safety (ACOPS) with the regular appointment cycle but not re-advertise for Planning Commission and ACOPS.

The Council took a 10-minute recess at 5:37 PM.

The Council provided direction to the Town Clerk on which committees to advertise for volunteers.

### 18-021 Governance - Discussion #8

Mr. Burke presented the three remaining Governance topics: use of Statement of Direction for non-SUPs; parameters for Town Manager work groups with Council Members; and supervising structure for the Town Attorney.

The Council discussed draft language amending Town Code Section 2-5-1(C) regarding statements of direction. The Council offered edits and directed the Town Manager to prepare an ordinance for Council consideration.

Mr. Burke noted that Council Members often volunteer to provide their knowledge and assistance with the Town Manager's development of a policy initiative. He suggested it would be appropriate for the Council to agree upon certain parameters for such work groups in the future. There was consensus to prepare an amendment to the Town Council Rules of Procedure clarifying Town Manager work groups.

The Council discussed the coordination and communication among the Town Attorney, Town Manager, and Town Council. It was agreed that no action was required on this topic.

# 18-037 Experience Scottsdale Report

Council Member Stanton provided an update on the activities of Experience Scottsdale and stressed the importance of the Town's participation. He circulated the agenda for the next meeting and asked for feedback. He stated regular updates would be given in the future.
