#### 2. STUDY SESSION ITEMS

18-385 Discussion of Major Special Use Permit Amendment - Statement of Direction (SUP-18-06). 10555 N Tatum Boulevard - Mountain View Medical Center

Senior Planner Paul Michaud presented the edits to the Statement of Direction (SOD) for the Major Special Use Permit Amendment for the Mountain View Medical Center as discussed at the October 11

# 18-402 Visually Significant Corridors Master Plan Discussion #3

Community Development Director Jeremy Knapp presented the edits to the Visually Significant Corridors Master Plan based on the Council's direction at the October 11<sup>th</sup> study session. There were no additional edits but there was a request for more information on costs to construct and maintain median islands on Lincoln Drive.

Mr. Knapp stated the Master Plan would be scheduled for a vote on November 1, 2018.

# 18-405 Discussion and Direction Regarding SUP Managerial Amendment Process

Town Attorney Andrew Miller presented a proposal to amend the Special Use Permit (SUP) Managerial Amendment process. He noted that during the September 27, 2018 study session, the Council raised a concern that there is not currently a process to appeal SUP Managerial Amendments. Based on those discussions, the Attorney's Office drafted potential Town Code amendments. After Council discussion, there was consensus to develop an ordinance with the following points:

- 1. Managerial decisions are subject to appeal by the Town Council
- 2. A minimum of three Council Members are required to start the process to appeal a Town Manager-approved amendment. Upon receipt of at least three written requests for an appeal, the Town Manager will schedule the item for consideration on a future Council agenda.
- 3. A Council meeting must be held within seven calendar days of the Town Manager's decision.
- 4. The Town Council's review shall be a two-step process. First, a majority of the Council must vote to decide whether to the Town Manager's decision meets the criteria for a Managerial Amendment. If the Council decides that the criteria have been met, then there shall be no further appeal and the Managerial Amendment is final. If the Council decides that the criteria have not be met, the Town Council may deny the Managerial Amendment, in whole or in part, or reclassify the application to a different category of Special Use Permit amendment.

There was Council consensus to formally refer this matter to the Planning Commission for further study and recommendation.

# 18-397 2019 Legislative Agenda and Strategy

Deputy Town Manager Dawn Marie Buckland and Doug Cole, Highground Public Affairs Consultants, discussed the upcoming legislative session. They reported on the upcoming election, legislative leadership and committee appointments for 2019, and anticipated legislative temperament toward cities and towns.

The Council discussed legislative interests and gave direction on edits to the 2019 Legislative Agenda document. The Town would continue to focus its attention on construction sales tax, public

safety/traffic enforcement, state-shared revenues, use of rights-of-way, local control over zoning authority, and a sustainable pension structure.

Ms. Buckland announced that a legislative breakfast is scheduled for January 10, 2019 and discussed other strategies to engage with legislators throughout the session.

# 18-403 Consideration of Ordinance Number 2018-16; Amendments to Article XVI, Home Occupation, Section 1603, of the Town Zoning Ordinance

Mr. Miller presented Ordinance 2018-16; adding a section to Article XVI of the Zoning Ordinance prohibiting persons, as part of a home occupation activity, park, or cause or allow to be parked, a motor vehicle that is visible from a street or adjacent property unless such vehicle is parked upon a driveway on the property that is surfaced with asphaltic concrete, pavement bricks, cement concrete, or a material that is paved, compacted, or chemically stabilized to prevent fugitive particulate matter.

The Planning Commission recommended approval.

# 18-416 Approval of Town Manager Employment Agreement

Vice Mayor Bien-Willner announced that the Town Council retained the executive recruiting firm CPS HR Consulting to conduct a nationwide search for a new Town Manager. More than 60 applicants applied for the position. The applicants were vetted and a final pool of three highly qualified candidates were selected for interviews.

Vice Mayor Bien-Willner moved to authorize the Mayor to sign an employment agreement with Mark C. Perkins to serve as Town Manager. Council Member Pace seconded the motion which passed by the following vote:

# 18-395 Consideration of Major Special Use Permit Amendment - Statement of Direction (SUP-18-05). 7101 E Lincoln Drive - Smoke Tree Resort

Community Development Director Jeremy Knapp presented the Statement of Direction for the Smoke Tree Resort Major Special Use Permit Amendment that had been discussed by the Town Council on September 27 and October 11.

Planning Commission Chair Daran Wastchak asked for clarification on the Council's position regarding the proposed for-sale units.

Taylor Robinson, representing Smoke Tree Resort, stated that the for-sale product would be individually owned units and have the same FFE as the resort rooms, but renting would be optional. If the owner chose to rent, it would be rented through the resort. He said their intention was to process the for-sale product as a Condominium Plat.

Some Council Members expressed concerns with the for-sale product. No amendments to the Statement of Direction were proposed.

A motion was made by Council Member Stanton, seconded by Council Member Dembow, to approve the Statement of Direction for Smoke Tree Resort. The motion carried by the following vote:

Council Member Dembow announced that the 14<sup>th</sup> Annual Paradise Valley Veterans Appreciation Vintage Car Show would be held on Saturday, November 10<sup>th</sup> at Town Hall.

Council Member Stanton reported that the Paradise Valley Arts Board hosted an Art Opening featuring photography of the Grand Canyon by Ed Lowry. The exhibit will be in Hall through September 2019.

Vice Mayor Bien-Willner reported that he attended the MAG Regional Council yesterday where regional transportation policy was discussed.

18-386 Discussion of Intermediate Special Use Permit Amendment Statement of Direction (SUP-18-10). 5410 N. Scottsdale Road Paradise Valley Medical Plaza

Planner George Burton presented a request by Paradise Valley Medical Plaza to amend their Special Use Permit to allow for the addition of a new 10,000 square foot medical building, a new parking area, and two new covered parking canopies.

Mr. Burton explained the recommended Statement of Direction (SOD) which included direction to the Planning Commission to focus on use, traffic/parking/circulation, signage, and impact to adjacent uses.

Following Council discussion, there were no amendments or additions to the SOD. There was consensus to schedule the SOD for a vote on November 15, 2018.

18-406 Discussion and Direction Regarding Code Amendments Related to the Processes Required to Amend the General Plan

Town Attorney Andrew Miller presented a draft ordinance to define the review and approval process timeline for Major General Plan amendments. As proposed, the annual deadline for filing an application for a Major General Plan Amendment was the second Thursday of April of each year.

The Council suggested including a process flowchart in the ordinance. There was consensus to schedule the draft ordinance for a vote on November 15, 2018.
