## TOWN COUNCIL MEETING 6401 E. LINCOLN DRIVE PARADISE VALLEY, ARIZONA 85253 MINUTES Thursday, January 24, 2019

#### 1. CALL TO ORDER / ROLL CALL

#### 2. STUDY SESSION ITEMS

## 19-033 Discussion of Lincoln Drive Median Improvements

Town Engineer Paul Mood presented the following two recommendations for Lincoln Drive median design between Mockingbird Lane and the Town's eastern border.

## 1. Shared Access and 40 mph Speed Limit

- Shared full access for Smoke Tree Resort and Lincoln Medical Plaza located approximately 86' west of shared property line
- Median Left turn pocket with 90' taper and 115' storage

- Dedicated right turn deceleration lane with 90' taper and 100' storage
- Eliminate western Smoke Tree Resort driveway
- Eliminate western Lincoln Medical Plaza driveway
- Provide shared access easement between Smoke Tree Resort and Lincoln Medical Plaza
- Provide non-vehicular access easement along Lincoln Medical Plaza eastern and southern property lines
- Provide full median access at Applewood Pet Resort's western driveway
- Provide further research into left turn only median opening at Gordon property

## 2. No Shared Access and 40 mph Speed Limit

- Provide full median access for Smoke Tree Resort
- Provided dedicated right turn deceleration lane for Smoke Tree Resort
- Eliminate western Smoke Tree Resort driveway
- Eliminate western Lincoln Medical Plaza driveway
- Provided dedicated right turn deceleration for Lincoln Medical driveway
- Provide non-vehicular access easement along Lincoln Medical Plaza eastern and southern property lines
- Provide full median access at Applewood Pet Resort's western driveway
- Provide further research into left turn only median opening at Gordon property

The Council discussed the recommendations and asked for additional analysis that takes into consideration: future traffic volumes and its impact on reasonable and prudent speeds; consider pedestrian crossing lights; and look at other median break options in front of Applewood Pet Resort and residential properties on the south side of Lincoln.

# 19-009 Paradise Valley Medical Plaza - Discussion of Intermediate Special Use Permit Amendment (SUP-18-10). 5410 N. Scottsdale Road

Planner George Burton presented a request by Paradise Valley Medical Plaza located at the southwest corner of Scottsdale Road and Jackrabbit Road to amend their Special Use Permit to allow for the addition of a new 10,000 square foot medical building, a new parking area, two new covered parking canopies and signage. The Planning Commission forwarded a recommendation for approval, with stipulations, by a vote of 6 to 0.

In response to questions raised by neighboring property owners, the Council requested more information on the traffic plan and the outcome of the applicant's meeting with the neighbors.

19-006 Sanctuary Resort - Discussion of an Intermediate Special Use
Permit Amendment - Statement of Direction (SUP-18-03). 5700 E
McDonald Dr -1st Review

Community Development Director Jeremy Knapp presented a draft Statement of Direction for a Special Use Permit Amendment application submitted by the Sanctuary Resort and Spa to allow for the

expansion of Casa 3 (or Gallery House) to add four new attached guest rooms, relocate the swimming pool, and add a new landscaping.

The Town Council discussed the application and the draft Statement of Direction. They provided feedback to staff regarding noise, density, setbacks, Hillside review of the project, and pedestrian access. The Council questioned how the concept of lot coverage should be considered regarding this resort property in general and this application in particular.

Mayor Bien-Willner recessed the meeting at 5:55 PM.

She stated that the increase in traffic, noise, and devaluation of neighboring homes would be a negative impact to the neighborhood and children's safety.

Resident Andy Gordon addressed the Council regarding the proposed improvements to Lincoln Drive from Mockingbird Lane to the Town's eastern border. He asked to the Town to consider alternatives to the staff recommendation. He expressed a preference for right and left turning movements into and out of his property.

Resident Donald McElmury asked the Council to consider traffic calming and beautification improvements to 64<sup>th</sup> Street.

# 19-026 Authorization of Expenditure to Implement the FY 2018-19 Pavement Maintenance Program

Public Works Superintendent Jerry Cooper presented a request to utilize the M.R. Tanner unit pricing contract awarded in March 2018 to mill and overlay Maintenance District 13, and crack seal and apply Polymer Modified Master Seal in Maintenance Districts 10 and 15. The total project cost was \$1,680,745.22.

Council Member Dembow announced that the next HOA Forum would be held on February 21 from 3:30 PM to 5:00 PM.

Mayor Bien-Willner praised the MLK event at Town Hall and the large attendance. He stated that he plans to invite more of the Town's young achievers to Council meetings to be recognized and lead the Pledge of Allegiance.

Council Member Moore thanked the Attorney's Office and Mayor Bien-Willner for representing the Town at the EPCOR water rate case hearing at the Corporation Commission.
