# 19-415 Arbor Day Tree Planting Ceremony

The Mayor and Town Council planted a tree near the Town Hall Reflection Path to commemorate Arbor Day.

19-421 Discussion on the Designation of State Funding for Public Transit Programs

Chief Financial Officer Douglas Allen presented options for using the Town's allocation of Arizona Lottery Funds for public transit services. The Council discussed using the funds for sidewalk construction, refurbishing bus stops, constructing bus stop bays, rideshare vouchers to ease parking

congestion at trailheads, or returning the funds to the state for redistribution. Initial research found that sidewalk construction would not be an allowable use of funds and the Town's bus stops are in good condition. The Council requested the following additional information: 1) does the Town own adequate right-of-way to construct additional bus bays on Tatum Blvd; and 2) would rideshare vouchers be an allowable use of funds under the Local Transportation Assistance Fund program guidelines.

Ms. Keimach stated that staff would report back in January.

# 19-420 Discussion of Lincoln Drive Median Improvements West of Mockingbird Lane

Town Engineer Paul Mood and Kim Carroll from Kimley-Horn and Associates, Inc presented draft design plans for Lincoln Drive median island improvement project. The purpose of the project was to:

- 1. Reconstruct, modify, and add new medians to meet MAG design standards and generally improve traffic safety
- 2. Install irrigation to medians east of Tatum Blvd.
- 3. Install new landscaping
- 4. Provide conduit for future intelligent transportation system improvements (conduit for fiber)
- 5. Lincoln Dr. and Invergordon Rd. intersection improvements
- 6. Lincoln Dr. and Tatum Blvd. enhanced crosswalk design

These improvements were in anticipation of resurfacing Lincoln Drive with rubberized asphalt in the spring of 2021. Staff was directed to publish the plans and the Town's website and schedule this item for a future meeting to provide additional review and public comment.

### 19-427 Update and Discussion of the CIP and PSPRS Financial Plans

CFO Doug Allen, Managing Director Mark Reader with Stifel, and attorney Paul Gales with GreenbergTraurig presented information, options, and reasons why the Town might consider issuing tax-exempt bonds to finance capital projects and free up general fund expenditure limit capacity to accelerate the pay off of Public Safety Personnel Retirement liabilities.

The Council authorized staff to proceed with the preliminary steps necessary for public sale and private placement bonds to test the market and report back to Council by February 27, 2020. The Council would make a decision at that time whether to authorize the sale or placement of bonds.

Mr. Allen presented a resolution declaring the Town's intent to reimburse certain capital improvements made within 60 days before and after the date of adoption. This resolution is necessary if the Town Council decides to issue bonds.

The Council discussed providing maximum flexibility in the reimbursement of expenditures as provided for in Section 5 of the resolution.

### 19-419 Discussion of 2020 Legislative Agenda

Doug Cole, Chief Operating Officer with Highground, Inc and Town Manager Jill Keimach reviewed the proposed legislative agenda for 2020. The Council offered additional edits. There was consensus to schedule it for adoption on December 5<sup>th</sup>.

# 19-418 Major Special Use Permit Amendment (SUP-18-05) Smoke Tree Resort 7101 E Lincoln Drive

Community Development Director Jeremy Knapp presented the revised Special Use Permit submittal by Gentree LLC, the property owner of Smoke Tree Resort located at 7101 E Lincoln Drive. After the initial application was recommended for denial by the Planning Commission in March 2019, the applicant made a presentation to Council. There was Council consensus that the proposed project was too dense and there was opposition to the for-sale condo element.

Mr. Knapp summarized the changes that had been made since the spring including the elimination of the for-sale product, lowering the hotel unit count, and reconfiguration of the building layout. The Council discussed next steps including whether the Council should hold a public hearing on the revised application or refer the application back to the Planning Commission.

The Council expressed concern for the requested "bubble zoning" and the dispute over ownership of Lincoln Drive in front of the resort. The Council requested more information on the rooftop bar and how it would impact neighbors. Taylor Robinson, representing the owner, responded to questions from the Council.

There was Council consensus to direct staff to review the amended application in terms of the current Statement of Direction and resort guidelines and report back to Council. The decision on how to proceed with the application review process would be made at that time.
