20-079 Discussion of Phase I Development Agreement for Lincoln Plaza

Medical Center

Town Manager Jill Keimach reported that negotiations are ongoing with regard to the Lincoln Plaza Medical Center Development Agreement. She stated that the item would be rescheduled for the next meeting.

20-071 Update and Discussion of the CIP and PSPRS Financial Plans

Chief Financial Office Douglas Allen and STIFEL Managing Director Mark Reader updated the Council on responses from the public and private markets to the Town's potential bond offer.

The Council favored the public sale because of the more favorable interest rate and because residents would have the opportunity to invest in the bonds. The Council directed staff to further investigate the 6.5-year public sale with a three-year callable option, while at the same time preserving options for a private placement to provide rate protection. The Council further directed staff to investigate the possibility of upgrading the Town's credit rating.

20-066 Discussion of Alarm Program Next Generation Services

Police Chief Peter Wingert updated the Council on the Police Alarm Monitoring program and subscriber history. He discussed the possibility of offering customers with enhanced technology services, such as smart thermostats, door locks, lighting, and garage door that are controlled through remote applications. He discussed a proposed business plan and marketing strategy.

There was Council consensus to offer the enhances services to subscribers.

20-077 Discussion of Mayor's Forum for Paradise Valley Educators

Mayor Bien-Willner discussed the creation of a new Educator's Forum similar to the HOA forum. The purpose would be to provide an opportunity for information exchange between the Town and local schools and school district representatives. There was Council support to create the forum.

13. FUTURE AGENDA ITEMS

20-042 Consideration of Requests for Future Agenda Items

Town Manager Keimach summarized the future agenda schedule.

There were no motions to add any items to the future agenda list.

14. MAYOR / COUNCIL / MANAGER COMMENTS

Council Member Andeen reported that ACOPS met on February 11 and discussed committee terms. She announced that the next Coffee with a Cop will be Wednesday, March 4 from 7:00 AM – 9:00 AM. The Citizen Safety Forum will be held on March 5th from 5:00 PM to 7:30 PM at the Paradise Valley United Methodist Church. March 6th is Black Balloon Day when thousands of families across the United States will tie a black balloon outside their house to symbolize a loved one who is struggling with additions or has died form an overdose.

Council Member Dembow expressed appreciation for birthday well wishes and the birthday cheese cake made by Executive Assistant Sarah Meland.

Council Member Thomasson reported on the quarterly update from Experience Scottsdale. From 2018 to 2019 there was a 2% increase in occupancy, which was higher than the top 25 markets in the country. Total occupancy was 70.7% and there was a 4% increase in average daily revenue. She noted that Experience Scottsdale is partnering with the Arizona Anti-trafficking Network because human trafficking occurs in and around hotels.

Council Member Pace announced that on February 17 the authors of The Real Story of Camelback Mountain would reading their book at the Desert Botanic Garden at 10:00 AM and Noon. Proceeds from the sale of the book benefit the Paradise Valley Mountain Preserve Trust. She announced that the Trust has received two conservation easement donations and is accepting fee title to a third parcel later this month.

Mayor Bien-Willner announced that he will be speaking at an LAI event on February 20, 2020 to discuss short-term rentals.

15. STUDY SESSION CONTINUED

20-064 Discussion of Public Works/Engineering Building Design

Town Engineer Paul Mood and DWL Architect Michael Braun discussed the proposed Public Works / Engineering Building expansion and remodel. Mr. Mood discussed the space needs assessment and Mr. Bruan described the conceptual design plans.

There was Council consensus to authorize staff to prepare a contract for design services.

20-072 Discussion of Hillside Safety Manual

Mr. Mood summarized the Hillside Safety Manual and provided an update on its implementation and enforcement, as well as, comments received from the development community. He recommended amending the manual to require the Safety Improvement Plan Insurance at the demolition stage rather than the construction stage. The Council agreed with the recommendation and asked staff to investigate the feasibility of requiring varying amounts of liability coverage based on the project size and scope.

There was Council consensus to add the Hillside Safety Manual text into Section 5-10-9 of the Town Code instead of keeping it as a separate document.
