### 2. ACTION ITEMS

# 20-132 Adoption of Resolution Number 2020-08; Authorizing Public Meeting Action Plan

Town Attorney Andrew Miller summarized Resolution Number 2020-08 which detailed the actions the Town would take in response to the COVID-19 disaster declarations issued by the President of the United States and Governor of Arizona. The Resolution provided the following:

- 1. Town Manager, Town Attorney, and Town Clerk to prepare a Public Meeting Action Plan
- 2. A quorum of Public bodies of the Town may attend meetings remotely
- 3. Mayor to exercise authority in Town Code to take actions consistent with the recommendations of the Center for Disease Control, The Arizona Department of Health Services, and other public health agencies regarding limiting public gatherings.
- 4. Town Manager authorized to implement remote working procedures for certain Town
