A motion was made by Council Member Moore, seconded by Council Member Thomasson, to adjourn. The motion carried by the following vote:



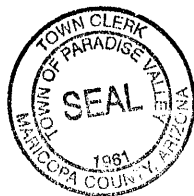
