# 21-074 Discussion of Pad Heights for Non-Hillside Lots

Community Development Director Lisa Collins provided an update on the Planning Commission's review of ordinances related to building pad heights for non-hillside lots. She summarized proposed Code amendments that would limit building pad heights to not exceed 2 feet from lowest natural grade; and clarify

that the building pad for any structure and the elevated surface for any area on a lot including, but not limited to, outdoor living spaces, auto courts, outdoor recreational areas and landscaped areas shall not exceed two feet as measured from the lowest adjacent natural grade.

It was agreed that Council Members would provide any additional feedback or comments on the draft Code language to staff and Vice Mayor Stanton (in his role as liaison to the Planning Commission), and the comments would be shared with the Planning Commission at their next meeting as they finalize their review and recommendations.

# 21-073 Consideration of Ordinance 2021-01 Amending the Town Zoning Ordinance to Prohibit Recreational Marijuana Establishments

Acting Town Attorney Deborah Robberson presented draft Ordinance 2021-01 prohibiting marijuana establishments and testing facilities in Paradise Valley for reasons including the lack of any appropriate retail zoning districts in the Town, the potential high-volume quick trip traffic that might be generated.

She noted that the Ordinance included an Emergency Clause. She explained that immediate operation of the provisions the Ordinance was necessary to preserve the public peace, health and safety as Proposition 207 authorizes marijuana establishments and testing facilities to use flammable materials for chemical extraction or chemical synthesis, resulting in a threat to the public's health, safety, security and peace and increases the responsibilities of law enforcement and other Town departments to respond to violations of state and local laws, including building, electrical and fire codes.

Mayor Bien-Willner opened the public hearing. There were no public comments. Mayor Bien-Willner closed the public hearing.

One-Year Extension and Approval of the Implementation of the
Lincoln Drive Resurfacing Project

Public Works Superintendent Jerry Cooper requested authorization to extend the Pavement Preservation Maintenance contract with M.R. Tanner that was awarded in 2018 after a competitive bid process for one year.

He presented a proposal to mill and overlay Lincoln Drive with rubberized asphalt. The Project would be implemented in two phases. Phase 1 would be the installation of ADA curb ramps in March through May 2021. Phase 2 would be the mill and rubberized asphalt overlay from 32nd St to Mockingbird Lane from May through June 2021.

# 21-075 Discussion of Historic Property Recognition Program Recommended by Historical Committee

Town Manager Jill Keimach summarized the current Historic Property Recognition Program and amendments recommended by the Historical Advisory Committee at their October 2020 meeting. The Committee recommends creating a two-level recognition program. The first level would be for homes that were in existence prior to Town Incorporation (1961). These homes would be recognized without further evaluation. The second level would be those homes that are at least 50 years old and if the property retained enough original materials, features, and/or characteristics necessary to convey its significance visually and represent an important part of the history or architecture of the Town using the existing evaluation criteria.
