On March 1, 2021 the Town posted a Notice of Intent to Award a contract to Gust Rosenfeld, P.L.C. She reviewed the terms of the proposed contract.

Doug Cole, with Highground Public Affairs, updated the Council on bills relevant to Paradise Valley. He focused on construction sales tax, photo radar, tourism marketing authority, public nuisance noise, attorneys' fees, repealing the criminal charge on civil matter related to repossessed vehicles, and short-term rental.

21-087 The 2022 General Plan - Community Survey Summary report and discussion on future community outreach efforts (Discussion Hubs)

Special Projects Planner Loras Rauch and Matthew Klyszeiko with Michael Baker International reported on the results of the 2022 General Plan Community Survey. A total of 365 surveys were returned equating to a confidence level of 95% and a margin of error of 5%. He announced that the results would be uploaded to the General Plan website for the public to view.

Mr. Klyszeiko explained that the results of the Community Survey will help to focus the discussion topic for the two upcoming Discussion Hubs.

- Discussion Hub #1 Congestion, cut through traffic, safety (vehicle, pedestrian and bike), and cell service.
 - Discussion Hub #2 lot splits, resort redevelopment, hillside development, and stormwater management.

He noted that short term rentals and building pad heights were frequently mentioned in the responses, but they would not be included as discussion items in the Discussion Hubs since the Town Council is already reviewing those topics in a separate public process.

The Council provided feedback on the Discussion Hub meetings.
