22-039 Informational Item on the Town of Paradise Valley Water Supplies by Senior Research Fellow of the Kyl Center for Water Policy, Kathleen Ferris

Paradise Valley resident Kathleen Ferris, a Senior Research Fellow for the Kyl Center for Water Policy at ASU's Morrison Institute for Public Policy, presented and discussed water supplies for

Arizona in general and specifically in Paradise Valley.

There was Council consensus to schedule this topic for further discussion and to consider a program to promote outreach, education, and voluntary water conservation in the Town.

22-054 Discussion regarding the Submittal for certain ARPA funds for the First Phase of our integrated IT Service Model Strategy (Digital Citizens Services) related to the Town's Finance Budget and Planning Technology Improvements.

James Bailey, Interim CIO explained that in October 2021, the Town Council considered technology projects for American Rescue Plan Act (ARPA) funding. The Council authorized proceeding with projects related to technology backup protection and cyber security monitoring. Staff was also directed to research and develop a proposal to improve the Town's citizen services in the areas of finance, budgeting, capital improvements planning, and planning and building permitting. He presented a two-phase plan. Phase 1 would be procurement of a software platform called ClearGov to improve efficiencies and transparency in budgeting. Phase 2 would be to procure technology for Community Development citizen services.

There was Council support for the initiatives using ARPA funding. Town Manager Keimach stated that Phase 1 would be scheduled for a vote at the next meeting.

22-046 Presentation of Paradise Valley Vintage Car Show Proceeds to the Sentinels of Freedom and the Military Assistance Mission

Mayor Bien-Willner stated that the Annual Paradise Valley Veterans Appreciation Vintage Car Show is a great community event when residents can share their love of cars, socialize with neighbors, and honor our nation's veterans. Former Mayor and Co-Chair of the Paradise Valley Veterans Appreciation Vintage Car Show Ed Winkler announced that the event held last November raised over \$14,000 and would be divided equally between the Sentinels of Freedom and the Military Assistance Mission. Wyn Tyner representing Sentinels of Freedom and Margy Bons representing the Military Assistance Mission described the work their organizations do.

22-050 Recognition of the Government Finance Officers Association Awards for the Town's Comprehensive Annual Financial Report, Popular Annual Financial Report (PAFR), and Budget Document

Mayor Bien-Willner announced that the Town of Paradise Valley has been recognized by the Government Finance Officers Association with the prestigious Triple Crown Award. The Triple Crown recognizes governments who have received the GFOA's Certificate of Achievement for Excellence in Financial Reporting, Popular Annual Financial Reporting Award, and Distinguished Budget Presentation Award.

12. ACTION ITEMS

22-053 Discussion and Action Concerning Ordinance 2022-03 Amending the Paradise Valley Town Code Regarding Nuisances, Unruly Gatherings, Non-Compliant Short-Term Rentals, and the Peace, Health, Safety, and Welfare of the General Public

Attorney Michael Goodman explained that the Town has devoted public resources over the last three years responding to negative impacts on neighborhoods from non-compliant short-term rental properties. Proposed Ordinance 2022-03 seeks to address these public health and safety concerns under the authority granted to municipalities by A.R.S. § 9-500.39. The Council held public discussions of the ordinance on September 23, October 28, November 18, 2021, and January 13, 2022. The result from those discussions are code amendments that fall within the limitations state law and would:

- Expand the definition of "special events" to capture problem activities
- Require standard health & safety measures to protect renters
- Expand existing noise regulations to address nuisance issues
- Make emergency contact numbers publicly available.

He noted that the ordinance includes a requirement for the Town Manager to prepare and present a report to the Town Council not later than one year regarding the implementation and effectiveness of these code amendments.

Mayor Bien-Willner opened the meeting for public comments.

Interim Chief Financial Officer Michael Carbone stated that the Popular Annual Financial Report (PAFR) summarizes the financial activities of the Town with brief analysis of where the Town's revenues come from, where those dollars are spent, and trends in the local economy. The document supports the Town's goal of promoting transparency and public confidence in financial reporting.

Public Works Superintendent Jerry Cooper presented a request to approve a one-year extension to the pavement management contract with M.R. Tanner Development and Construction and authorize an expenditure in the amount of \$2,491,680.45 for roadway maintenance in Districts 5, 12, and portions of District 13. He noted that M.R. Tanner would honor the same contract pricing as last year. He described the maintenance that would be done in each district, the timeline, and costs.
