1. CALL TO ORDER / ROLL CALL

Mayor Bien-Willner reconvened the Study Session at 3:17 PM.

22-282 Discussion and Direction to Staff Regarding Request to Revert the Rules & Procedures Regarding Future Agenda Items on the Council Agenda back to the March 2012 Code

Mayor Bien-Willner summarized the legislative history of the section in the Town Council Rules and Procedures related to the process by which members of the Council can add items to a future agenda. Currently, three votes are required for a Council Member to place an item on an agenda. He suggested reverting back to the section that was in effect in 2012 which required four votes. He noted that any Council Member may also make a request directly to the Mayor or Manager to place an item on the agenda.

22-280 Discussion of Statement of Direction Andaz Resort Intermediate Special Use Permit Amendment 6160 N Scottsdale Rd & 6041 N Quail Run Rd

Senior Planner George Burton summarized an application submitted by PV Hotel Venture SPE LLC (Andaz Resort) for an intermediate Special Use Permit Amendment to incorporate and develop 6041 N Quail Run Rd into the resort with 10 single-story guest units, a new one-story service building, and new perimeter walls. He stated that during the first Council study session, the discussion focused on:

1. The primary issues or areas of concern are noise, setbacks of all proposed structures, and an

assurance that the proposed guest units will not be "for sale product" (e.g., a resort residential subdivision).

- 2. The proposed fence all adjoining Quail Run Rd should align with the existing fence wall to the north.
- 3. The residential standards listed in the SOD, staff report, and staff generated documents shall be removed.
- 4. Update and streamline SOD item No. 5. The Town Engineer shall review the Grading & Drainage plan for code compliance.
- 5. Staff must provide more analysis on the Quail Run Road right-of-way dedication and improvements for Council review (e.g. provide a "pros and cons" list for developing or landscaping the dedicated portion of Quail Run Rd right-of-way).

The Council discussed in detail the draft Statement of Direction and provided additional comments.

There was consensus to schedule the revised Statement of Direction for a vote at the next meeting.

22-283 Discussion and Possible Direction to Staff Regarding the Substance of Ordinance 2022-06, Amending certain Provisions of Chapter 10 of the Town Code, to Incorporate Recent Changes in Legislation

Town Attorney Andrew McGuire summarized the changes made to the draft ordinance amending Article 10-14 of the Town Code related to short-term rental requirements since the last meeting. He explained the proposed administrative appeals process. He clarified that the grounds for denial and revocation are limited to submitting an incomplete application, providing false information, or permits mistakenly issued. The appeals process would follow the same appeals process in Article 4 with the Town Manager making the final determination. On the other hand, appeals for suspensions, which are tied to the statutory process for verified violations, would be assigned to a hearing officer designated by the Town Manager. Hearing officers could be a judicial officer or someone other than Town staff. The Hearing Officer would have the authority to suspend a license for a period of at least three months and no more than 12 months.

Responding to a concern from a resident, the Council discussed the proposed requirement to require the short-term rental property owner to "deliver" a written notice to adjoining neighbors. It was discussed that residents may be more comfortable contracting the Town to verify the location of a rental property.

There was Council consensus to remove the notification requirement from the draft ordinance and, instead, focus on communicating options for residents to find the locations of rental properties online or by contacting the Town.

22-281 Discussion of the Proposed Mockingbird Lane Improvements from Lincoln Drive to McDonald Drive

Capital Projects Administrator Jason Harris discussed the proposed Mockingbird Lane improvements from Lincoln Drive to McDonald Drive to bring the roadway up to minor arterial roadway standards. The Town applied for and received grant funds from the Congestion Mitigation and Air Quality Improvement Program administered by the Maricopa Association of Governments. The improvements include minor widening of the roadway in limited areas, adding vertical curb and gutter to address drainage issues, a new sidewalk and driveway adjustments, and bike lanes.

There was Council consensus to proceed with the design as presented. Direction was given to include sidewalks on both sides of the street and a 6-foot bike lane between the curb and chicanes.
