## **RECOMMENDATION:**

## SUMMARY STATEMENT:

Section 2-5-3.A of the Town Code states, "The Board of Adjustment shall, at its first meeting in April of each year, elect one of its members to serve as its Chairmandesignate. The member designated to be Chairman shall be approved or disapproved for the Chairmanship by the Town Council within thirty (30) days of the election by the Board of Adjustment.....No member shall serve as Chairman of the Board for a period of time in excess of two (2) consecutive years." Board Member Ozer has served two consecutive terms. She was was elected as Chair on April 6, 2022, then re-elected April 27, 2023. Therefore, the Board of Adjustment must elect a new Chair-designate at the April 3<sup>rd</sup> meeting.

## 5. PUBLIC HEARINGS

### A. 24-085 Discussion and Possible Action on Case No. BA-23-07 Kourouglos Variance - 8600 N Caballo Circle (APN 174-36-183) Variance to allow an addition to the house to encroach into Setback

Senior Planner George Burton presented the variance request to allow a garage addition to encroach into the 40' front yard setback. He compared the zoning ordinance to the request, including a proposed setback of 20'. Mr. Burton presented visual renderings, an aerial photo, and site photos of the property then proceeded to discuss the site conditions, history

of the lot, analysis, and scope of the request. A petition of support had been provided. Mr. Burton noted that staff believed that based on the property hardships, a variance was warranted.

Boardmember Barnes asked if the existing garage was within the building envelope, and if the new garage would accomplish/accommodate 6 cars in tandem. This information was confirmed by staff.

Attorney for the applicant, Wendy Riddell, discussed impacts of the current setbacks due to the property having three front designations and a drainage easement bisecting the property. She noted that a complete analysis of the neighborhood had been completed, and shared details from that analysis.

Boardmember Barnes complimented the presentation by Ms. Riddell.

Boardmember Leibsohn wondered if the property owner to the North signed the petition of support.

Ms. Reddell advised that the property owner to the North had signed the petition.

Boardmember Williams asked if the existing garage under the roof counted toward the overall 7,000 sq ft under roof.

Ms. Riddell stated it was counted, and the new garage addition would be counted as well since it will be connected to the main home.

The public hearing was open and closed at 5:49 PM. No public comment was received.

Boardmember Leibsohn believed that the required variance criteria had been met and stated he would be voting in favor of the request.

### A motion was made by Boardmember Leibsohn seconded by Boardmember Kuykendall to approve the variance in accordance with the stipulations in the staff report. The motion carried with the following vote:
