#### **BACKGROUND**

The applicant requests this continuance in an effort to continue to work on alternatives. Also, the requested continuance is in response to the circumstance that meeting notification procedures occur generally two months prior to the Town Council date to accommodate Planning Commission meetings and advertisement deadlines.

#### State Statute

Pursuant to State Statute, a major amendment application to a General Plan must be presented at a public hearing to the Town Council within the same calendar year it was filed. The subject application
