### AGENDA TITLE:

Consideration of Resolution No. 2020-12, Authorizing the Town Manager to Enter into an intergovernmental agreement (IGA) to join the Arizona Mutual Aid Compact with the Arizona Department of Emergency and Military Affairs (AzDEMA) and participating counties, cities, towns, tribal governments and fire districts

### RECOMMENDATION:

Adopt Resolution Number 2020-12; authorizing the Town Manager to execute an intergovernmental agreement to join the Arizona Mutual Aid Compact with the Arizona Department of Emergency and Military Affairs and other participating jurisdictions.

### SUMMARY STATEMENT:

The Arizona Mutual Aid Compact (AzMAC) is a multiparty intergovernmental agreement between the AzDEMA and many participating counties, cities, towns, tribal governments and fire districts. The agreement assures that Arizona's public safety, when faced with an emergency incident that could exceed a single jurisdiction's ability, can quickly and efficiently request, provide and be reimbursed for mutual aid in an orderly fashion by using procedures that they all understand and have agreed upon in advance of the incident. The Town of Paradise Valley desires to be a signatory on the AzMAC.

Short-term mutual aid between law enforcement agencies occurs frequently by a phone call or police radio request. During short-term mutual aid, reimbursement is not sought by the provider. The AzMAC covers long-

term mutual aid and provides the ability for a providing agency to seek reimbursement from the requesting agency. For example, the AzMAC could assist Paradise Valley Police maintain resident safety if a significant percentage of Paradise Valley police personnel were unavailable due to illness.

The AzMAC runs in ten-year periods and would need to be reapproved by the Council in 2030. The AzMAC becomes effective as soon as the IGA is approved and executed by the Town. The IGA will also need to be filed with the Secretary of State. If the Council desires to terminate prior to the completion of the ten-year period, the Council can provide a 20-day notice of such and pass a resolution requesting termination of the Town's participation in the AzMAC. Termination by other members does not affect the Town's participation in the AzMAC.

**BUDGETARY IMPACT:**

There is no cost to join the AzMAC. The Town of Paradise Valley is responsible for any resource requests that are filled through this agreement in the case of an emergency incident. If Paradise Valley Officers are requested by another municipality as a long-term solution, the Town could request reimbursement from the requesting agency.
